



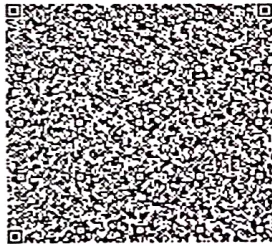

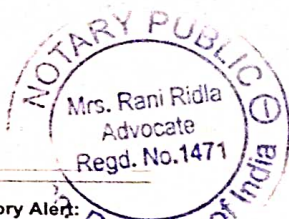



 - v. That no part of income from the institution shall be diverted to any individual in the Society registered, School Management Committee or to any other person. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school.
 - vi. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
 - vii. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
 - viii. That state pattern classes IX to XII running prior to affiliation of CBSE would be sponsored at State Board Examination & State Pattern Classes IX to XII will be closed in a phased manner & State Pattern Class IX to XII will not be opened on conferring upon Affiliation from CBSE.
